**Eligibility Ages:** LifeLock® services are available to employees and their spouses age 18+. Protection for dependent children is available from birth to age 26. Upon reaching age 18, enrolled dependent children will receive whatever level of protection the employee selects.

**Portability:** An employee/member has the option to continue LifeLock protection by paying the LifeLock membership fee directly to LifeLock within 31 days after employment terminates. LifeLock will charge the membership fee directly to the employee/member's credit card.

**Availability and Participation:** In order to make LifeLock enrollment available, an employer group must allow the option of enrollment in at least one Transamerica Life Insurance Company product. There is no group minimum participation for LifeLock service. Transamerica product participation requirements vary by state.

**How to Apply:** Your organization can apply by providing Transamerica with your completed Group Application and Agreement, together with a copy of this proposal. LifeLock will notify employees enrolled in LifeLock® services on their group effective date.

**Enrollment:** Enrollment information will be managed through spreadsheet enrollment.
