**Guidelines:**

By Florida Statute, students registered in a home education program may request part-time enrollment at the secondary level in the District assigned public school of attendance. The following guidelines apply for enrollment of home education students in secondary coursework:

1. Home education continues to be the student's primary educational program. Responsibility for compliance with state requirements pertaining to the Home Education Program remains with the parent.
2. Enrollment requests may be for one (1) or more courses, but no more than three (3) courses per semester.
3. Enrollment is based on availability of space, as determined by the school administration.
4. As with any other student, prerequisite requirements for a requested course must be met prior to enrollment in the course.
5. The student/family is responsible for any course related fees charged to full-time students enrolled in the same course.
6. The parent is responsible for the student's transportation. Space on a regular bus may be available when the student's arrival/departure times coincide with bus schedules.
7. The student must arrive at and depart from the campus according to times designated by the school administrator.
8. The student is required to abide by all rules and regulations as provided in the School Board approved *Student Code of Conduct*, including regulations for parking and driving on campus.
