JOB GOAL: Responsible for management of human resources functions with a focus on recruiting and retention, employee records management, and personnel support, while ensuring efficiency and compliance with Board and union agreements, district policies, and federal/state statutes for all employee groups in order to attract and retain a diverse, high-performing workforce. This is a high level managerial position, which supervises other managerial and supervisory personnel.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Assist with directing and coordinate, through subordinate supervisory personnel, activities of workers responsible for recruiting, hiring, and retention; employee records management; and providing personnel support.
2. Provide direction to and supervise assigned personnel, conduct annual performance appraisals, and make recommendations for appropriate employment actions.
3. Assist with development of departmental policies and procedures, revising procedures as needed to increase efficiency of the department's services; and ensure appropriate documentation is maintained and updated.
4. Assist with interpretation and implementation of applicable district, state, and federal policies, laws, and regulations, including union agreements and contracts.
5. Provide oversight for employee records management, ensuring accuracy of data and compliance with all applicable laws and regulations.
6. Oversee recruiting, hiring, and onboarding efforts for the District, including substitute placement, fingerprinting, assisting hiring administrators in the recruitment process, and improving diversity; and recommend system improvements as needed.
7. Review and provide final approval for related personnel Board agenda items, including appointments, transfers, promotions, and other employee actions.
8. Assist with development and implementation of the Human Resources Leadership Development (HRLD) Plan.
9. Communicate with other administrators, district personnel and vendors to coordinate recruiting, hiring, and retention efforts, resolve issues and conflicts, and exchange information.
10. Maintain contact with other school districts, colleges and universities, governmental agencies, and professional management associations to develop partnerships and keep abreast of laws, regulations, statutes, policies, current research, and best practices related to human resources.
11. Serve on multiple committees, councils, and/or task forces to support the District's vision, mission, goals and strategic priorities, which may include serving on one or more of the Board's negotiating teams to assist with the collective bargaining process.
12. Provide cost impact analysis as requested, complete required and/or ad hoc reports, and maintain department records.
13. Assist with development and maintenance of the departmental budget.
14. Respond quickly to emergency situations and serve as a district representative at emergency shelters as determined by the Superintendent.
15. Perform other duties as assigned

Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.

F	Reaching	Extending hand(s) and arm(s) in any direction
O	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward .
O	Pulling	Using upper extremities to drag, haul, or tug objects in a sustained motion.
O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
R	Grasping	Applying pressure to an object with the fingers and palm.
F	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
F	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
R	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
