**JOB GOAL:** Responsible for performing in-depth analysis and reconciliation of all premium revenue and claims and administration fee expenses each month. This includes preparing and reporting monthly results to finance, the District Insurance Committee, and insurance companies.

#### ESSENTIAL DUTIES & RESPONSIBILITIES:

*The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. 1. Reconcile premiums paid to ensure the District and employees are being expensed correctly.
2. Calculate all monthly administration fees to be paid for self-insured plans.
3. Verify the accuracy of COBRA and retiree premiums paid to the District each month by a third party administrator.
4. Work within the annual benefits budget and fund balance deficits to calculate premium rates to be charged each benefit year.
5. Update all electronic plan data annually associated with open enrollment.
6. Calculate payroll adjustments for premium deductions.
7. Analyze monthly revenue to claims for employees, retirees, and COBRA participants.
8. Monitor and oversee invoicing and payment of premiums due for employees on a leave of absence.
9. Develop standard processes to establish and maintain consistency and efficiency.
10. Prepare various ad hoc report requests.
11. Run queries to perform audits and analysis of data to resolve discrepancies.
12. Provide customer and employee support as needed.
13. Participate on various committees
14. Performing other duties as assigned.
