JOB GOAL: Responsible for planning, coordinating, performing, and monitoring functions and services related to certification of personnel. This includes supervision of staff, ensuring consistency in day-to day operations, and performing analysis to ensure compliance with applicable state and federal legislation.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Serve as team lead for employees responsible for providing guidance to instructional and administrative personnel for obtaining and maintaining certification.
2. Supervise, evaluate, train, and delegate work to appropriate staff; and make recommendations for employment.
3. Plan, organize, and coordinate activities related to certification of personnel, ensuring accuracy and compliance with district, state, and federal guidelines.
4. Develop and implement certification policies and procedures to increase effectiveness and efficiency of certification services, and make process improvements as appropriate.
5. Monitor and counsel out-of-field teachers to ensure compliance with state legislation, while minimizing the number of out-of-field teachers in the District.
6. Advise administrators regarding personnel certification status to recommend course placement options.
7. Communicate certification requirements, including any changes in district, state or federal guidelines, to various stakeholders.
8. Collaborate with district- and school-based administrators to identify areas of need related to teacher certification in order to provide recommended plans.
9. Serve as a liaison to coordinate certification procedures between Human Resources, schools, departments, instructional employees and the Florida Department of Education.
10. Analyze applicants' and employees' certification eligibility to ensure compliance with Florida Educator Certification requirements.
11. Resolve discrepancies and exceptions on all matters pertaining to teacher certification in personnel systems.
12. Oversee development and preparation of a variety of certification reports for ongoing customer needs.
13. Update and maintain certification records within the District's employee data system.
14. Perform other duties as assigned.

O	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion.

O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
R	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
R	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
