JOB GOAL: Responsible for providing support to district networks by installing, trouble-shooting, and maintaining computer hardware, software, and data communications equipment, while also supporting end users. This includes maintaining accurate inventory records and adequate levels of network related supplies/equipment to ensure efficient operations of the department and district.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Place supply and equipment orders as needed to maintain adequate inventory on-hand and to ensure efficient and timely update or repair of network devices.
2. Receive inventory for placement into the department's warehouse.
3. Issue inventory to network staff according to documented processes and procedures.
4. Identify and report obsolete inventory to management to allow for the resale of outdated stock.
5. Maintain a computerized inventory system to help manage parts and ordering needs.
6. Organize, prepare, and participate in the annual inventory count of supplies and equipment.
7. Assist the network administrator in requirement analysis and network application evaluation, design, and implementation.
8. Assist in developing comprehensive plans for development, review, implementation, coordination, and evaluation of school and district network programs and services.
9. Assist in the configuration, implementation, and support of new or existing network equipment.
10. Inspect and review all work related to network and telephone cable infrastructure in accordance with all local, state and federal regulations using Building Industry Consulting Service International (BICSI) standards and methods.
11. Coordinate technical assistance and training to assigned staff and end users, including repairs, moves, and equipment changes.
12. Install, maintain, and troubleshoot hardware, software, and data communications equipment.
13. Coordinate with various telecommunication contractors and/or telephone company providers to ensure efficient operations and limit network down time.
14. Assist with supervision of staff when needed.
15. Perform other duties as assigned.

F	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward.
F	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion.
F	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
R	Grasping	Applying pressure to an object with the fingers and palm.
R	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
