**JOB GOAL:** Responsible for supporting the planning, coordinating and implementing of district network systems and associated applications.

#### ESSENTIAL DUTIES & RESPONSIBILITIES:

*The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. 1. Assist with the evaluation, design, implementation and support of new and existing network equipment, server systems, and software platforms.
2. Assist with monitoring network performance, troubleshooting network problems, and scheduling updates to systems and related technology.
3. Assist with network requirement analysis to help identify strengths and weaknesses within the system, and various operating platforms to ensure functionality, integration, and efficient operations.
4. Assist in developing comprehensive plans for program review including, development, implementation, coordination, and evaluation of new and existing network equipment and services.
5. Assist in the audit of network equipment to ensure efficient operations and compliance with district, state, and federal laws, rules and guidelines.
6. Assist in designing, monitoring, and implementing network specifications for educational facilities, technology systems, and other related technology equipment and materials.
7. Assist and/or complete required reports for appropriate local, state and federal educational agencies.
8. Research and evaluate emerging technology trends to ensure district equipment and department operations are relevant to modern standards and in compliance with local, state, and federal regulations.
9. Assist in providing guidance and input for on-site network transport and installation based on industry standards and design specifications.
10. Provide technical assistance and training to end users on topics associated with network services, security, and other related technology issues.
11. Coordinate with various telecommunications contractors and/or telephone company providers to ensure efficient operations and limit network down time.
12. Attend professional development workshops related to network services to better understand emerging technology and information services trends and changing regulatory requirements.
13. Supervise and allocate work to assigned staff.
14. Perform other duties as assigned.

F	Twisting	Moving body from the waist using a turning motion
F	Reaching	Extending hand(s) and arm(s) in any direction
F	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward
F	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion
F	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm
R	Grasping	Applying pressure to an object with the fingers and palm.
R	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
