#### Retirement Services Coordinator

**JOB GOAL:** Responsible for coordinating activities related to retirement services and performing advanced, specialized, complex duties related to administration of the District's retirement plans. This includes analyzing work processes and reviewing work related to the administration of the Florida Retirement System, 403(b) voluntary retirement plans and retiree group health plans to ensure accuracy, efficiency and timeliness.

#### ESSENTIAL DUTIES & RESPONSIBILITIES:

*The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.*

1. Act as a liaison between FRS and the District to provide assistance to employees regarding retirement services.
2. Develop and prepare retirement services communications and educational materials for employees/retirees.
3. Coordinate and provide educational seminars or one-on-one counseling to employees regarding retirement programs.
4. Respond to participant inquiries regarding plan features/provisions, and coordinate with outside agencies as necessary.
5. Determine retirement eligibility and guide employees through the retirement process.
6. Maintain accurate records to effectively administer the District's retirement plans and retiree health benefits, including reconciliation of premiums.
7. Train and mentor other retirement services staff in all aspects of administration, compliance and customer service related to retirement services.
8. Continually review processes and make recommendation for changes to enhance productivity and add value to the administration of retirement services.
9. Coordinate monthly and annual open enrollment for retiree health benefits.
10. Effectively audit and identify discrepancies in retirement benefit calculations, data and information.
11. Serve as a liaison to coordinate workflow and procedures between retirement services and other departments, including financial services, information services, school-based personnel and third party administrators.
12. Perform other duties as assigned.

#### PREFERRED QUALIFICATIONS:

- Bachelor's degree from an accredited institution.
- Knowledge of statutory requirements of retirement plans.

**SUPERVISORY RESPONSIBILITY:** Direct supervision of assigned personnel. Responsibilities includes planning, assigning and directing work; addressing complaints and resolving problems; training employees, evaluating performance; and assisting with interviewing, testing, and hiring personnel.

#### PHYSICAL REQUIREMENTS *(Describes physical conditions of this position):*

<input checked="" type="checkbox"/>	Sedentary Work	Exerting up to 10 pounds of force occasionally and/or a negligible amount of force frequently to lift, carry, push, pull or move objects. Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.
<input type="checkbox"/>	Light Work	Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force frequently. If the use of arm and / or leg controls require exertion of forces greater than that for sedentary work and the worker sits most of the time, the job is rated as Light Work.

R	Reaching	Extending hand(s) and arm(s) in any direction
O	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward.
O	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion.
O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use

R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
O	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
R	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
R	Visual Acuity	The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.
