**JOB GOAL:** Responsible for designing and developing effective, safe, and efficient bus routes.

#### ESSENTIAL DUTIES & RESPONSIBILITIES:

*The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.*

1. Plan, schedule, monitor, and coordinate school bus routes using computerized routing system software to maximize safe and efficient bus use.
2. Work with Transportation Field Specialists to monitor and analyze arrival, layover, and departure times, student load data, driver input, and other related information to implement routing and scheduling adjustments that ensure the safety and efficiency of the transportation system.
3. Coordinate route and stop change notifications with all stakeholders including: families, schools, management, and bus drivers to ensure successful implementation.
4. Work with the Office for Student Support Programs and Services to determine exceptional-student needs and transportation service requirements.
5. Prepare and maintain required reports and records including, but not limited to, Florida Educational Finance Program (FEFP) surveys, route sheets, and route/stop change documentation, while ensuring privacy and confidentiality statutes compliance.
6. Work with the Planning Department and the GIS Analyst to establish and maintain the mapping system and attendance boundaries by updating and editing the map for additions or changes to roads within the District's planned routes.
7. Ensure compliance with Board policy and governmental regulation as it relates to the department.
8. Provide basic computer and software support for assigned area of responsibility.
9. Maintain detailed records of route/driver observations to document and provide relevant statistics and related information regarding students transported and transportation services provided.
10. Communicate professionally and effectively with parents, the public, and all school board employees to ensure positive relationships are maintained while meeting all of the goals of a safe, efficient transportation system.
11. Disseminate schedule and driver assignments and changes to drivers and schools.
12. Perform other duties as assigned.

Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.

S	Twisting	Moving body from the waist using a turning motion.
O	Reaching	Extending hand(s) and arm(s) in any direction
O	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward.
O	Pulling	Using upper extremities to drag haul or tug objects in a sustained motion.
O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles.
F	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.

O	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
R	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
R	Visual Acuity	The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.
