JOB GOAL: Responsible for planning, evaluating, designing, and setup of new server based applications while maintaining and supporting district-wide server based applications.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Assist in the support of a variety of application systems requiring cross-platform integration, including importing/exporting of data, account credential creation, automation, interfacing, and other related tasks.
2. Monitor and maintain system applications, log files, disk space, and various database systems for usage levels, patterns, and anomalies and address any corrective action necessary to ensure productivity.
3. Coordinate and develop backup routines and systems for network servers and applications to ensure data integrity and system productivity.
4. Troubleshoot software and hardware issues and determine corrective and preventative measures required to maintain optimal server operation levels.
5. Assist in refining policies and procedures related to technology usage, including data sharing, data privacy, and data protection to ensure they fall within federal, state, local regulations and requirements.
6. Research and evaluate emerging technology trends to ensure district hardware and software are up to industry standards and best practices.
7. Develop integration strategies that identify server improvement or replacement opportunities and make recommendations to management for upgrade/replacement requirements.
8. Design training and develop documentation that ensures effective and efficient use of technology to aid end-users and other stakeholders.
9. Assist in preparing budgets for server repairs, replacements, and purchases.
10. Perform other duties as assigned.

O	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion.
O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
O	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips

R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.

F	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
