JOB GOAL: Responsible for investigating, researching, and defining data processing applications in a mainframe computer environment by analyzing current procedures, defining problems, making recommendations for revisions of existing processes or institution of new systems, determining their feasibility for computer processing.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. 1. Document and prepare work flow diagrams and procedures that establish formal standards and aid in writing computer programs.
2. Identify potential computer application area needs and upgrade opportunities based on end user needs and district initiatives.
3. Provide technical assistance and training to end-users and staff to ensure standard and efficient operation of various software and hardware platforms.
4. Coordinate with end-users and department staff to determine system requirements and possible upgrades necessary to maintain proper functionality and that conform to established protocols.
5. Write, test, and de-bug complex programs to ensure the needs of the school system and end-users are being met while complying with local, state, and federal requirements.
6. Review existing hardware and software for possible enhancement opportunities and make recommendation for improvement as needed.
7. Design forms and specifications for district software and hardware usage to ensure system security and efficient operations.
8. Implement system and software upgrades to ensure proper installation and to make sure that they work within the established parameters and guidelines.
9. Perform other duties as assigned.

O	Reaching	Extending hand(s) and arm(s) in any direction
O	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward.
O	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion.
S	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
O	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.

F	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
F	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
F	Visual Acuity	The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.
