**JOB GOAL:** Responsible for managing the safe, efficient transportation of students to and from school and school related activities for a designated area.

#### ESSENTIAL DUTIES & RESPONSIBILITIES:

*The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.*

1. Supervise and monitor the daily operations of designated transportation routes, including daily dispatch activities, bus routes, and assignment of extra-curricular trips.
2. Supervise assigned personnel, evaluate performance, make recommendations for appropriate employment actions, and assist with all aspects of the hiring process and placement of employees.
3. Ensure timely and appropriate response to accidents and incidents.
4. Collaborate with maintenance staff to ensure that proper care and safety standards are being followed and all federal, state, and local rules and regulations are met.
5. Collaborate with other area managers to ensure efficient coverage of all routes, and inform administration of potential problems and unusual events.
6. Interact with school personnel, other government agencies, parents, and the general public to facilitate a proactive approach to resolving issues.
7. Apply knowledge of state and federal laws and regulations, Department of Education rules, and School Board policies and procedures to ensure compliance.
8. Maintain records and prepare required reports regarding transportation operations utilizing computer software applications such as spreadsheets and databases.
9. Audit bus routes to ensure efficiency.
10. Perform other duties as assigned.

#### MINIMUM REQUIREMENTS:

<input type="checkbox"/>	Sedentary Work	Exerting up to 10 pounds of force occasionally and/or a negligible amount of force frequently to lift, carry, push, pull or move objects. Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.
<input checked="" type="checkbox"/>	Light Work	Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force frequently. If the use of arm and / or leg controls require exertion of forces greater than that for sedentary work and the worker sits most of the time, the job is rated as Light Work.
<input type="checkbox"/>	Medium Work	Exerting up to 50 pounds of force occasionally, and/or up to 20 pounds of force frequently and/or up to 10 pounds of force constantly to move objects.
<input type="checkbox"/>	Heavy Work	Exerting up to 100 pounds of force occasionally, and/or up to 50 pounds of force frequently, and/or up to 20 pounds of force constantly to move objects.

F	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward
F	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion
R	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm
F	Grasping	Applying pressure to an object with the fingers and palm

O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips

R	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly
R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels
