JOB GOAL: Responsible for planning, organizing, coordinating, and monitoring safety and environmental programs and functions, while ensuring compliance with local, state, and federal regulations. This includes developing and coordinating emergency operations programs such as hurricane preparation and shelter operations.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Coordinate, plan, and oversee district safety and environmental functions and programs.
2. Supervise, evaluate, train and delegate work to appropriate staff; and make recommendations for employment.
3. Oversee the storage and removal of hazardous materials throughout the district.
4. Coordinate comprehensive fire safety and indoor air quality assessments to ensure the safety of students, staff, and other stakeholders.
5. Review various safety reports related to fire safety and indoor air quality and coordinate corrective actions as needed.
6. Coordinate and ensure compliance with EPA, OSHA, and Health Department Standards.
7. Coordinate disaster response and crisis management activities such as opening shelters and implementing special needs plans and activities.
8. Provide disaster preparedness and other safety training to district staff and other stakeholders.
9. Collaborate with district officials to analyze and prepare damage assessments following disasters or emergencies.
10. Coordinate the District's hurricane preparation and shelter operations plan.
11. Develop and maintain contacts with local officials and government entities in order to facilitate plan development and response efforts.
12. Respond quickly to emergency situations and serve as a district representative at emergency shelters as determined by the Superintendent.
13. May have to work non-standard hours during emergency situations.
14. Perform other duties as assigned.

MINIMUM REQUIREMENTS:

Requirements are representative of minimum levels of knowledge, skills and/or abilities. To perform this job successfully, the incumbent will possess the abilities or aptitudes to perform each duty successfully. Reasonable accommodations may be made to enable qualified individuals with disabilities to perform the essential functions.

KNOWLEDGE, SKILLS & ABILITIES:

- Knowledge and experience in applying safety principles, practices, technologies, and techniques
- Knowledge of emergency management planning
- Ability to organize and coordinate emergency management and shelter operations prior to and during natural disaster situations
- Ability to communicate effectively with a variety of audiences, orally and in writing, including electronic media
- Ability to organize, prioritize, manage and carry out duties efficiently and within established timeframes
- Must meet the physical requirements of Post Offer Employment Testing (POET)

EDUCATION, TRAINING & EXPERIENCE:

- Bachelor's degree from an accredited institution in public management, occupational health, or a related field

- Completion of the FEMA Incident Command System (ICS) to include 100, 200, 300, 400 and National Incident Management System 700 and 800 within one year of employment
- Valid Florida driver license
- Must maintain a driving record that meets the standards of the District Safe Driver II Plan. Driver license must be maintained as a condition of continued employment

PREFERRED QUALIFICATIONS:

- Master's degree from an accredited institution in public management, occupational health, or a related field
- Emergency management experience
- Five (5) years experience in a safety management related field

SUPERVISORY RESPONSIBILITY: Direct supervision of assigned personnel. Responsibilities include planning, assigning, and directing work; addressing complaints and resolving problems; training employees; evaluating performance; and interviewing, testing, hiring, and assignment of personnel.

PHYSICAL REQUIREMENTS *(Describes physical conditions of this position):*

<input type="checkbox"/>	Sedentary Work	Exerting up to 10 pounds of force occasionally and/or a negligible amount of force frequently to lift, carry, push, pull or move objects. Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.

If the use of arm and / or leg controls require exertion of forces greater than that for sedentary work and the worker sits most of the time, the job is rated as Light Work.
<input type="checkbox"/>	Medium Work	Exerting up to 50 pounds of force occasionally, and/or up to 20 pounds of force frequently and/or up to 10 pounds of force constantly to move objects.
<input type="checkbox"/>	Heavy Work	Exerting up to 100 pounds of force occasionally, and/or up to 50 pounds of force frequently, and/or up to 20 pounds of force constantly to move objects.
<input type="checkbox"/>	Very Heavy Work	Exerting in excess of 100 pounds of force occasionally, and/or in excess of 50 pounds of force frequently, and/or in excess of 20 pounds of force constantly to move objects.

O	Reaching	Extending hand(s) and arm(s) in any direction
S	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward

S	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion
S	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles
O	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
O	Grasping	Applying pressure to an object with the fingers and palm.
S	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
O	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
F	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
F	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
F	Visual Acuity	The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.
