JOB GOAL: Under direct supervision, responsible for providing specialized clerical support for the department with a focus on employee benefits, benefits administration, and/or risk management. Responsibilities include maintaining accurate employee data, processing related forms and documents, and providing customer service.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Accurately set up, maintain, and audit benefit records.
2. Provide customer service to applicants, employees and retirees, providing information and responding to basic inquiries regarding benefits and other related topics.
3. Assist with administration of employee benefits, including the processing and submission of benefit enrollments; facilitating applicable payroll deductions; and coordinating group insurance billing of employees on leaves of absence, COBRA participants and retirees.
4. Assist with the administration of retiree benefits, including the processing and submission of retirement applications; disseminating retirement literature and basic information; and verifying and reconciling remittance of health premiums.
5. Assist with the administration of occupational health and risk management programs, including the processing and submission of workers' compensation, property and liability claims.
6. Coordinate distribution of information to schools and district departments by maintaining communications with work site representatives; and provide benefits information and assistance to staff.
7. Perform clerical and record keeping tasks to include word-processing, filing, copying, scanning, data-entry, answering phones, preparing simple reports, and sorting mail.
8. Perform other duties as assigned.

Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.
<input type="checkbox"/>	Light Work	Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force frequently. If the use of arm and / or leg controls require exertion of forces greater than that for sedentary work and the worker sits most of the time, the job is rated as Light Work.
<input type="checkbox"/>	Medium Work	Exerting up to 50 pounds of force occasionally, and/or up to 20 pounds of force frequently and/or up to 10 pounds of force constantly to move objects.

F	Twisting	Moving body from the waist using a turning motion.
R	Reaching	Extending hand(s) and arm(s) in any direction
O	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward exerting up to _____ pounds of force
O	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion exerting up to 20 pounds of force.
O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles exerting up to 20 pounds of force.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
R	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
R	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
