JOB GOAL: Responsible for the technical operation of a variety of computer systems and the coordination of all computer processing schedules and operations, including the administrative support requirements for the operation of the computer center.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Schedule updates and processes for all computer applications to ensure they meet current business standards and best practices.
2. Monitor the operations of all host computer systems and peripheral hardware to ensure they remain within the proper functional parameters.
3. Recommend and develop improved procedures by continually evaluating computer operations to make sure they conform to established guidelines, policies, and best practices.
4. Coordinate with data entry operators and help desk staff to ensure accurate and timely processing cycles.
5. Assist in providing security and confidentiality for the data maintained by the department as required by local, state, and federal regulations.
6. Monitor job logs to ensure completion of routine program runs.
7. Establish and monitor an effective backup system schedule for local and remote storage and for the archival of all systems data as required by district policy and agency requirements.
8. Maintain procedure manuals, computer processing run logs, and other required documents to comply with local, state and federal requirements.
9. Monitor systems for performance, capacity, and availability to ensure efficient use of resources and effective output of various systems.
10. Maintain adequate inventories of all computer forms, magnetic media, and other supplies.
11. Monitor the computer room environment to safeguard the operational requirements of power backup, air conditioning, and other support systems and equipment.
12. Perform other duties as assigned.

Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.

O	Crouching	Bending the body downward and forward by bending leg and spine.
S	Crawling	Moving about on hands and knees or hands and feet.
O	Twisting	Moving body from the waist using a turning motion.
F	Reaching	Extending hand(s) and arm(s) in any direction.
O	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward.
O	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion.
O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
F	Grasping	Applying pressure to an object with the fingers and palm.

F	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.
F	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
F	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
R	Visual Acuity	The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.
