JOB GOAL: Responsible for performing maintenance, delivery, diagnostics, and repair of Food and Nutrition Services electronic vending machines to provide an environment that supports healthy food habits while maintaining program integrity and customer satisfaction.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Trouble-shoot and perform diagnostics on electronic vending machines to ensure they are programmed correctly and are in proper working order.
2. Assist FNS Specialist in identifying ideal locations for new or relocated vending machines taking into account walking/traffic patterns, health and safety rules, existing electric and data, accessibility etc.
3. Perform installations and relocations for new and existing electronic vending machines, ensuring they are clean and in proper working order.
4. Review automated service help desk requests to plan the most efficient and cost effective route
5. Maintain parts inventory to ensure timely repair of equipment and complete appropriate paperwork related to ordering and maintaining stock.
6. Assist in the training of school based FNS staff on maintenance, cleaning and troubleshooting of electronic vending machines.
7. Practice safe handling of FNS vending machines during stocking and transportation.
8. Clean and care for assigned vending service truck and replenish fuel as needed
9. Perform other duties as assigned

MINIMUM REQUIREMENTS:

To perform this job successfully, the incumbent will possess the abilities or aptitudes to perform each duty successfully. Reasonable accommodations may be made to enable qualified individuals with disabilities to perform the essential functions.

KNOWLEDGE, SKILLS & ABILITIES:

- Knowledge of Hazard Analysis Critical Control Points (HACCP), food safety and sanitization principles.
- Knowledge of computing systems, electronics, networks, and software required to manage, and troubleshoot electronic vending machines.
- Ability to communicate effectively with a variety of audiences, orally and in writing, including electronic media
- Ability to organize, prioritize, manage and carry out duties efficiently and within established timeframes
- Ability to apply basic math skills.
- Must meet physical requirements of the District's Post Offer Employment Testing (POET)

EDUCATION, TRAINING & EXPERIENCE:

- High School Diploma or equivalent
 - Two years of experience servicing vending machines, in operations, diagnostics, and repairs.

- Any equivalent combination of education and experience which provides the required knowledge, skills, and abilities to perform the essential duties and responsibilities of the position

PREFERRED QUALIFICATIONS:

- Successful completion of an accredited vending machine repair training program.
- Five years of vending route sales, and or repair work.
- Valid FLCDL-B driver license.

PHYSICAL REQUIREMENTS *(Describes physical conditions of this position):*

<input type="checkbox"/>	Sedentary Work	Exerting up to 10 pounds of force occasionally and/or a negligible amount of force frequently to lift, carry, push, pull or move objects. Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.

If the use of arm and / or leg controls require exertion of forces greater than that for sedentary work and the worker sits most of the time, the job is rated as Light Work.

R	Sitting	Resting with the body supported by the buttocks or thighs.

O	Twisting	Moving body from the waist using a turning motion.
R	Reaching	Extending hand(s) and arm(s) in any direction
R	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward.
R	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion.
R	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles .
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
O	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
F	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers.

R	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly.
R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
R	Visual Acuity	The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.
