JOB GOAL: Responsible for performing highly diversified craft trade activities with a focus on HVAC, carpentry, electric, plumbing, masonry, electronic, food service equipment repair, roofing, flooring, and/or site development under general supervision.

- 1. Perform skilled and semi-skilled trade work, including maintenance, construction, installation, and/or repair of buildings and facilities throughout the district.
- 2. Perform routine preventative maintenance to equipment and facilities within designated timeframes.
- 3. Perform mechanic skills including, but not limited to, mechanical, electrical, pneumatic, hydraulic, troubleshooting, and repair of production machines and plant facilities.
- Apply knowledge of multi-trades areas to general repair and minor construction duties involving school building structures, HVAC systems, carpentry, electric, plumbing, masonry, electronic, food service equipment repair, roofing, flooring, and site development.
- 5. Follow established safety protocols and handling procedures as prescribed by local, state and federal guidelines.
- 6. Provide emergency or unscheduled repairs of equipment or facilities when needed.
- 7. Use a variety of hand and power tools, meters, and material handling equipment when performing day-to-day job functions.
- 8. Report any unsafe working conditions to appropriate personnel.
- 9. Perform other duties as assigned.

	Sedentary Work	Exerting up to 10 pounds of force occasionally and/or a negligible amount of force frequently to lift, carry, push, pull or move objects. Sedentary work involves sitting most of the time. Jobs are sedentary if walking and standing are required only occasionally and all other sedentary criteria are met.
	Light Work	Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force frequently. If the use of arm and / or leg controls require exertion of forces greater than that for sedentary work and the worker sits most of the time, the job is rated as Light Work.
	Medium Work	Exerting up to 50 pounds of force occasionally, and/or up to 20 pounds of force frequently and/or up to 10 pounds of force constantly to move objects.

R	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
R	Grasping	Applying pressure to an object with the fingers and palm.
