JOB GOAL: Under direct supervision, responsible for providing advanced, specialized, administrative support. Responsibilities include assisting with the hiring process, onboarding of employees, maintaining accurate employee data, processing related forms and documents, and providing customer service.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. These statements are not intended to be an exhaustive list of all duties and responsibilities required of all personnel within this position.

1. Guide new hires through the on-boarding process to ensure timely completion of all required onboarding paperwork or other employment related requirements to ensure a smooth transition for all new employees.
2. Communicate directly with candidates and new hires at the direction of the Human Capital Partner.
3. Assist with the hiring process, including reviewing and posting job requisitions, confirming open allocations, reviewing applications for completeness, and other similar tasks.
4. Conduct routine screening and identification of applications relative to veterans' preference, criminal history, licensure actions, education, and employment history.
5. Accurately enter employee information into appropriate databases and/or systems; and process less complex personnel actions, such as terminations, extended school year assignments, and supplements.
6. Update various applicant and employee databases, including employment eligibility, interns, and candidate pools.
7. Coordinate, distribute, collect, and electronically file employment contracts and reappointment/non-reappointment notices.
8. Process employee paperwork, and assist with preparation of related information for Board agenda items.
9. Provide customer service to employees and applicants, providing information and responding to basic inquiries regarding the application process, employment, certification, compensation, benefits, and/or other personnel related questions through various means, including phone, email, and/or live chat.
10. Provide backup to the department as needed in other areas.
11. Perform other duties as assigned.

O	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward exerting up to ____ pounds of force
O	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion exerting up to 20 pounds of force.
O	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles exerting up to 20 pounds of force.
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm.
R	Grasping	Applying pressure to an object with the fingers and palm.
O	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips

R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels.
