JOB GOAL: Responsible for the digital conversion, storage, retrieval, and printing of records for schools and departments.

ESSENTIAL DUTIES & RESPONSIBILITIES:

The following statements of duties and responsibilities are intended to describe the general nature and level of work being performed by individuals assigned to this position. 1. Operate the digital scanning equipment for conversion of records and documents.
2. Organize, convert, and integrate files for digital conversion or storage.
3. Assist with the records destruction process in compliance with local, state and federal rules and regulations for retention.
4. Monitor digital conversion and storage activities by maintaining log of services.
5. Compile periodic reports related to conversion services.
6. Review record retention laws and guidelines regularly to ensure compliance.
7. Perform other duties as assigned.

<input type="checkbox"/>	Heavy Work	Exerting up to 100 pounds of force occasionally, and/or up to 50 pounds of force frequently, and/or up to 20 pounds of force constantly to move objects
<input type="checkbox"/>	Very Heavy Work	Exerting in excess of 100 pounds of force occasionally, and/or in excess of 50 pounds of force frequently, and/or in excess of 20 pounds of force constantly to move objects

F	Pushing	Using upper extremities to press against something with steady force in order to thrust forward, downward or outward
F	Pulling	Using upper extremities to drag, haul or tug objects in a sustained motion
F	Lifting	Raising objects from a lower to a higher position or moving objects horizontally from position- to-position through the use of the upper extremities and back muscles
R	Finger Dexterity	Picking, pinching, typing or otherwise working primarily with fingers rather than with the whole hand or arm
R	Grasping	Applying pressure to an object with the fingers and palm
R	Feeling	Perceiving attributes of objects, such as size, shape, temperature or texture by touching with skin, particularly that of fingertips
R	Repetitive Motions	Substantial and continuous movements of the wrists, hands, and/or fingers
F	Talking	Expressing or exchanging ideas by means of the spoken word. Those activities in which detailed or important spoken instructions must be conveyed accurately, loudly or quickly
R	Hearing Acuity	The ability of perceive speech and other environmental sounds at normal loudness levels
R	Visual Acuity	The power to see at a level which allows reading of numbers and text, operations of equipment inspection of machines, etc.
