Minutes**

September 29, 2016

Mr. Williams called the meeting to order at 10:30 a.m. and took questions from the committee. A question was asked what academies and programs were being offered at the new high school, and Monica Isle stated that Engineering/Robotics, Business/Entrepreneurship and Criminal Justice will be offered. Another question was asked about how the Middle School and High School students will be separated. District staff stated that the plan is to house students in separate buildings and the lunches and Physical Education classes will also be separate.

Mr. Williams went through the packet of information that was prepared for the committee and explained the various map options for discussion. It was agreed to not consider Option 6 as this option did not relieve Sunlake High School (SLHS). Other areas were discussed including the southwest area of the boundary, which is the eastern boundary of SLHS. Boundary Committee members also brought up other areas to consider. The high school and middle school groups continued to discuss the maps and boundaries until Mr. Williams brought the groups back together to share their thoughts and proposals.

The middle school group shared the following; areas 16, 17, 20, 21 going to Wesley Chapel High School (WCHS) and Thomas E. Weightman Middle School (TEWMS). Areas 2A, 2B, and 2C going to High School GGG. A second option was for areas 2A,

2B, and 2C going to Wiregrass Ranch High School (WRHS) and adding area 8 to areas 16, 17, 20, 21 going to WCHS and TEWMS.

The high school group shared the following; Option 1 and adding areas 16-23 to WCHS. Option 2 adding 16-23 going to Wesley Chapel HS, and did not look at touching area 2. The high school group asked if Sunlake High School could be considered with the West Side Boundary and it was stated that there was not an opportunity to consider this due to the high growth in Starkey Ranch, Asturia, Bexley Ranch and new development north of J.W. Mitchell High School.

The two groups resumed separate discussions. Discussion included; areas 16, 17, 20, 21 potentially going to WCHS and with State Road 56 being the dividing line between TEWMS and Dr. John Long Middle School (JLMS). Areas 18, 19, 22, 23 would potentially stay at JLMS.

Mr. Williams shared the middle school committee group recommendations; areas 16, 17, 20, 21, which are north of State Road 56 potentially going to TEWMS and group members not comfortable with areas south of State Road 56 going to TEWMS. Areas 2A, 2B, and 2C going to High School GGG or perhaps 2B and 2C going to HS GGG.

Mrs. Poe shared the high school committee group recommendations; areas 8, 15A, 16, 17, 20, 21 potentially going to WCHS.

The group asked for maps to be made based on the options mentioned above to see how the numbers add up.

For clarity, Mr. Williams summarized the options that the groups requested maps for;

Areas 2A, 2B, 2C, going to HS GGG or not going to HS GGG

Areas 16-23 WCHS & TEWMS as an option

Areas 16-23 drawing the line at State Road 56 with 16, 17, 20, 21 to WCHS/TEWMS and 18, 19, 22, 23 staying at JLMS/WRHS

Areas 8 and 15A splitting north and south areas

Areas 15A split into north of Chancey and 15C south of Chancey.

The group requested feeder patterns be added to the maps when they are made.

Before adjourning at approximately 12:30 p.m., Mr. Williams reminded the group that the next meeting would be held on October 20th at 10:30 at Wesley Chapel High school.
