Mr. Chris Williams called the meeting to order at 8:10 a.m. Mr. Williams welcomed the group and thanked them for serving on the committee and welcomed School Board member Alison Crumbley.

Mr. Williams started the meeting by asking the group which options they preferred in order to gauge the committee's thoughts and frame the meeting discussion. After taking a vote of the 5 options Mr. Williams then told the group that he would like to speak about the parent meeting and what was spoken at the meeting by the parents. Boundary committee members then shared what they heard from the parents that spoke at the parent meeting.

Committee members discussed boundary map areas that could be moved in and/or out of various school boundaries. Grandfathering of students of grades other than rising seniors was also discussed. Other topics discussed were address verification, delaying of the boundary, school choice, current growth, future growth, career academies and parents of certain areas not being notified of the boundary change.

After several hours of discussion of various map options, the committee eliminated Options 4, 4A, 5, 5A and 5B. A new map option 11 that had been submitted by a boundary member but was also eliminated. The committee directed staff to create option 4A-2, which is a modified version of option 4A, and option 5-2, which is a modified version of option 5. A vote was taken and 13 committee members voted for option 4A-2 and 12 committee members voted for option 5-2.

Mr. Williams thanked the committee for their hard work and reminded them of School Board meetings that will be held at 6:00 p.m. on December 20<sup>th</sup> and January 17<sup>th</sup>. The Board meetings will be held in Building 3 of the District office complex located at 7205 Land O' Lakes Boulevard.

The meeting was adjourned at 11:50.
