Elementary School “W”**

**SCHOOL BOUNDARY COMMITTEE
Minutes**

October 16, 2015

Chris Williams called the meeting to order at 10:05. Introductions were done. Chris Williams walked through the various attachments and maps regarding the timeline for the boundary process, the purpose, guidelines, goals for today’s meeting and the tasks for today’s meeting. The future growth that is coming to this area and where that would be located was also discussed as well as other future schools. The numbered areas were also discussed in general. One parent indicated that she believed Areas 19 and 21 belonged to Meadow Pointe II and not Meadow Pointe III. This will be checked with our MPUD records.

Chris Williams presented three proposals, done by the Planning department, as to areas to shift to create a boundary for Elementary “W” and balance out the populations for Denham Oaks, Double Branch, Sand Pine and Seven Oaks elementary schools. It was made clear that these proposals are done just to get the discussion started. It was stated that committee members could reject these ideas, offer other ideas, and ask for areas of discussion to be further split and/or analyzed.

The committee began by discussing the areas closest to the location for the new Elementary “W”. Areas 15-19 were discussed as areas to be rezoned from Sand Pine to “W”. It was suggested that perhaps Area 15 stay with Sand Pine and Area 16 be rezoned to “W”. This will be developed as an option.

Areas 20-28 were discussed as being rezoned from Double Branch to “W”. It was recommended and agreed by the committee that Area 28 should remain with Double Branch. It was also recommended and agreed that Areas 20 and 27 should

remain together and that they should be rezoned to Elementary "W". Areas 25 and 26 were discussed. There were pros and cons with rezoning these areas to "W" or keep with Double Branch. This will be developed as options to be considered further. The other areas were agreed to rezone to Elementary "W".

The remaining time was spent discussing the southern portion of the Seven Oaks boundary, how to divide these areas up, where they should go, the need to relieve Seven Oaks, how many students would we be comfortable with at Sand Pine, the abundant capacity available at Denham Oaks, and the traffic situation along SR 56 and County Line Road. No firm decisions on any particular areas. If we move a significant amount more students into Sand Pine than what is rezoned to Elementary "W" then we will need to spend money to move additional portables onto the Sand Pine campus. Planning was asked to divide Area 7 up into additional areas. Concern was raised about dividing this area up but it will be divided and brought back to the committee for review and discussion. Additional options will be developed by Planning which would include rezoning Areas 6 and 7 into Denham Oaks and Sand Pine. Other areas to consider are Areas 3, 4, 5, 8, 9 and 10. Again, additional options will be developed and emailed to the committee for further discussion at the next meeting. The Planning department was also asked to provide a 5-year projection for these schools based on the various options.

It was agreed to meet again on Tuesday, October 27 from 1:00 to 3:00 pm at Sand Pine Elementary. A Parent meeting will be held November 19 at 6:00 pm at Sand Pine Elementary.

The meeting was adjourned.
