**Recommendation**: Recommend acceptance of RFP from Prutsman & Stahl, P.A., per the attached RFP tabulation and interview scores tabulation, as having the highest average score and best RFP meeting written specifications.

<u>Term of Contract</u>: This is a three-year contract, renewable annually by mutual agreement of both parties, for a consultant to provide representation for the District on various issues before the Office of the Governor for the State of Florida, the Florida Legislature, and other agencies of the State. The aim is to ensure that State legislative and administrative actions are consistent with the views and interests of the District School Board.

Notations and Exceptions: The proposals were evaluated by committee members, with scores totaled and averaged to determine the final scoring. All four (4) firms were invited to interview with the committee on March 8, 2005, with scores having returned to "zero" for the interview sessions. The firms were again scored by the committee members after the interviews. It is the consensus of the committee that the services of Prutsman & Stahl be retained. Savings were calculated as the difference between the high and low bids, for a period of one (1) year.
