**Term of Contract:** This is an annual purchase for office products to be stocked in the central warehouse for use throughout the District.

**Notations and Exceptions:** Recommend acceptance of all lower bids as meeting the written specifications and testing criteria as specified in the bid documents with the following exceptions:

**OS-16:** Recommend acceptance of bid from Ace Office Supplies as best bid meeting written specifications. Lower bid from Standard Stationary Supply was evaluated and did not pass testing criteria; i.e., too thin and flimsy.

**OS-28:** Recommend acceptance of bid from Bye-Mor, Inc. as best bid meeting written specifications. Lower bid from Pyramid School Products and Business Stationers were evaluated and did not pass testing criteria; i.e., too thin and easily torn.

**OS-36:** Recommend acceptance of bid from Smith Office & Computer Supply as best bid meeting written specifications. Lower bids from Bye-More, Inc. and Pyramid School Products bid the same product. Product did not pass testing criteria; i.e., easily ripped, closing device was weak and uneven and rings are loose.
