Recommendation:

Recommend acceptance of bids as noted on attached bid tabulation sheet as lowest and best responsive, responsible bids meeting written specifications.

Term of Contract:

This bid is for the annual new, and replacement, athletic equipment for warehouse delivery and distribution throughout the District. Quantities in bid are anticipated requirements and are contingent upon availability of school funds.

Notations and Exceptions:

Items AE-202, 212 and 223: Awarded "All or None" to the same manufacturer as specified in bid documents.

Items AE-204, 441, 473, 474, 502, 628, 620, 621, and 905: Recommend rejection of low bid from Gametime Athletics. They have requested their bid be withdrawn for these item due to a pricing error on their part. Recommend award to Allen Sports Center for items 204, 441, 473, 474, 502 and 905, AAE for item 628 and M-F Athletics for items 620 and 621.

Item AE-205: Recommend rejection of low bid from Toledo Physical Education Supply. They have requested their bid be withdrawn for this item due to a pricing error on their part. Recommend award to Allen Sports Center.

Item AE-225: Recommend rejection of low bid from GL Sports for bidding helmet without face mask as required in the bid documents. Recommend award to Allen Sports Center.

Notations and Exceptions:

Items AE-404 and 932: Recommend rejection of items for failure to receive any bids for these items. Request permission to purchase on the open market after receiving competitive prices.

Items: AE-933 & 936: Recommend rejection of low bid from Gametime Athletics. They have requested their bid be withdrawn for these items due to a pricing error on their part. Request permission to purchase on the open market after receiving written quotes.

Although we received only one bid for some items, the bids are deemed competitive based upon past bid pricing structures.

Savings were based on historical usage.
