The Accident Scene

On Friday, March 26, 2009, members of the Pasco District Schools Transportation department along with Pasco Sheriff's Office, Pasco Fire NPR Fire and Police. Rescue, Community Hospital, and Pasco Emergency Management, conducted an emergency bus evacuation drill at Gulf High School. Additionally, members of the Mitchell High School drama team sheriff's **Explorers** volunteered to go under the makeup artist's brush to become the victims of a terrible bus crash. While we all hope that such an incident will never occur, the realistic drill serves to make all of the first responders, as well as those who support them from the various operations centers much more aware of their own roles in such a disaster.

Things began the day before when Tatum's Towing and Recovery hauled an old bus from the depot on Pine Hill Road over to the Gulf High School

parking lot beside the football field. Next, the bus was flipped over on its side. Then Fire Rescue took over. Knowing that they would have to cut an escape opening in the top of the bus, the decision was made to do this the night before the exercise to reduce the possibility of risk to the actors playing the victims.

Next morning, the actors entered one of the most intensive makeup sessions of their young careers and the other players gathered at the GHS Buccaneer football field for an explanation of how the day would go.

With the briefing complete, the action moved to the site of the crash, and when all was set, James Johnston of Pasco County EOC set the action in motion.

Radios crackled, sirens began to wail in the distance, and very soon the scene was alive with police and fire rescue personnel. Just as would happen in a real emergency, parents and members of the general public began to show up as well. The scene was soon roped off to keep the area clear for emergency personnel. Also within the zone were designated "observers" who were to report at the debriefing later just what they saw.

Her action prevented 5 students from serious injury or worse. The driver told Mrs. Butcher and she was rewarding these 5 students with "PRSmith Bucks."

Tears of gratitude flowed when a parent called the West Compound to compliment driver W. C. Rains. The mother stated that if not for the driver utilizing the hand signals her child would be dead or severely injured today. Her son started to cross the road at Jasmine Blvd. and Hilltop Dr. Noticing a car



approaching, Mr. Rains blew his horn and yelled for the kids to wait, just as the car blew through the bus' stoplights. The mother was so appreciative that the driver uses the hand signals every day. She feels that Mr. Rains is doing a great job looking out for the safety of her child.


People whose problems are all behind them are probably school bus drivers.
