(The purpose of this publication is to provide notice of a change in the room locations for these meetings, and a change in the start time of the May 5, 2020 meeting from those set by the School Board at its organizational meeting of November 2019 pursuant to sections, 1001.371, and 1001.372, Florida Statutes.) These changes are made to facilitate public access and participation in response to various Federal, State, and Local directives regarding the COVID-19 virus.
