Personally, I support the new tentative rezoned map put forth by the School Board and will be happy to remain at River Ridge next year. My son was rezoned to River Ridge at the beginning of his middle school career, so it was an easy transition for him to go from Longleaf Elementary directly into River Ridge. Having said that, however, I am sympathetic to my fellow Longleaf neighbors who had their children literally ripped from their home school mid-middle school or mid-high school career. It is the children that are being affected the most by all of this.

With the 2017-2018 rezone that was performed, many families from Longleaf had the opportunity to become established at River Ridge and now feel that it is their home school (our family included). Rezoning these children to SSMS/JWMHS at this time would accomplish nothing except for more turmoil. I do hope that you will take into consideration the families that would like to stay at SSMS/JWMHS for their child's middle school or high school completion (as well as offer them transportation).

I did not take the opportunity to attend the special meeting last week in our neighborhood with Cynthia Armstrong and I am not planning on attending the workshop tomorrow night. While the vocal support is for Longleaf to remain at SSMS/JWMHS, there is also a large group of families who are not overly vocal that would like to see Longleaf stay at River Ridge.

Bus transportation has been provided for both RR and SSMS/Mitchell for 2017/2018 school year and can continue as is. This will be needed due to choice , teacher/staff accommodation and special needs regardless for the 2018/19 year.

Comments on proposed map

(a) move Starkey Ranch to River Ridge Middle and High and Area 30 to Gulf as the Superintendent recommends; (b) leave Longleaf, Ellington and Sienna Woods (Area 12) at Mitchell and Seven Springs (c) reopen school choice to allow students who wish to go to or stay at River Ridge Middle and High to do so and to allow them to continue through grade 12 (d) provide bus transportation to both sets of schools. If additional relief of Mitchell and Seven Springs is needed, they can consider moving (a) The Preserve (aka South Branch Ranch) (b) Longleaf neighborhoods 4 and 5 since none of those neighborhoods are occupied yet. If more relief is needed, implement an address verification policy and system such as those in place in Palm Beach and Broward Counties, and we will cover the cost of the software license if needed. The reasons this plan is better are that it is the least disruptive to established neighborhoods and it achieves stability of the populations of Mitchell and Seven Springs for at least long enough for the K-8 school at Starkey Ranch to be built and opened.

Dear Mr Browning and the Pasco County School Board

My wife Tara and I adopted a little girl from the Philippines. Her name is Julianne. After taking 2-1/2 years to finalize the adoption process, she finally arrived in our home in Jan 2017. She was excited, anxious and of course a bit fearful with her new surroundings and going to a new school as a 6th grader for the first time in America.

You should know that during the last 3 years in the Philippines, she attended 3 different schools being moved around all the time. As I'm sure you can imagine, her experience coming to a new country, a new home and a new school was very challenging, with fears and emotions running wild.

Coming into SSMS as a 6th grader, half way through the school year, not having any friends and having to learn English and the new ways of education very quickly was an enormous attentive effort on the part of my wife and I and her sister, who by the way, graduated high school from Mitchel. Her first semester was not easy and very challenging and her teachers at SSMS were great in bonding with her and helping her adjust. I am proud to report that Julianne has adapted, learned and excelled in her studies that 1st semester in her new school in a new country and eventually made friends and became comfortable and secure with her new school and neighborhood.

Well, you can imagine the trauma with her when we all learned about the rezoning plans last year. Another change in schools would mean 5 new schools for her in just 4 years. How disturbing could that be for this little girl, new to this country and especially after getting secure and comfortable with her surroundings. There were lots of tears and conversations we had to have to calm her down and assure her that everything was going to be ok. Fortunately, she was accepted for 'Choice' and

was able to remain in SSMS. Although extremely inconvenient for my wife and I at the beginning because of having to change work schedules to accommodate dropping off and picking her up at the school because there was no bus service, it was still worth the sacrifice on our part. Now we have bus service and our life has become normal again.

With all that said, Julianne has really fit in and has completely adapted to her surroundings at SSMS this school year. She was promoted to 8th grade math and has made a lot of friends, not only with students, but with teachers as well. She feels secure and happy and the thought of uprooting her for her 8th grade and final year in middle school to yet a different school, is terrifying her.

The stress this will put on her and my family . . . again . . . is simply undeserving not fair. She needs to stay in the school she has grown to be accustomed to since arriving in America. Bottom line is that changing schools is not in the best interest of our child because of her past and all the challenges she has had to deal with already in the last 4 years.

My name is Christine Kalemba and I live at 8610 Sweetbriar Court in the Greenbrook Estates. I have been involved with this rezoning issue since the very beginning and I am sorry to see it's still going on. My husband and I bought our home in Greenbrook Estates many, many years ago just so our kids could go to SSES, SSMS and JWMHS. They have been going through all three schools since kindergarten. My son is in his Junior year of high school and my daughter is in 7th grade. And as is true for all homeowners, our home was and still is the one big investment of ours. We plan to retire here. We will continue to fight to keep our kids in their schools and we will fight to keep our home values increasing. Just because the County did not make infrastructural provisions for future growth, does not mean my family and our assets have to take the hit for it. This is of the County's doing and it is their responsibility to fix it and not at the expense of our kids or our home values. To not do so is fiduciary irresponsibility.

I am still of the opinion that it is the responsibility of the County to make sure that address verification should be done properly so that children who are properly zoned for the schools have the ability to attend the schools they are zoned for and not lose their seat to outsiders who aren't even legally zoned for that school. Now is the time to close SSES and any feeder schools, SSMS and JWMHS to those who are not zoned for these schools. No exceptions!

I am still of the opinion that it is not right to push out the older neighborhoods who have made this area what it is for new people who aren't even here yet. And there is still the pesky issue of home values going down once these older neighborhoods are rezoned to less attractive schools. You are not only affecting families with kids in those schools but also the home values of ALL residents in those neighborhoods. There is a real economic

impact caused by rezoning that can equate to a huge dollar amount that will affect the homeowners in the older neighborhoods you are thinking about rezoning.

I know Counties have a rainy day funds to take care of unexpected things. Maybe now is the time to use those funds to build new schools that will handle the over flow from the new homes being built just down the road on SR 54 in the newer developments like Starkey and such. Maybe it's time to build those new schools NOW rather than later. There are empty buildings in our area that can be used as annexes if need be until new schools can be built in areas that make sense. Have Marchman students make portables to handle the influx of new students while the new schools are being built. Add additional wings to current structures. Just do something instead of moving kids around like pawns and affecting our home values.

Like I said, I was active since the beginning and I will continue to fight this fight until the end. My kids and my neighbors are worth it. We didn't make this mess. The County did and it's the County's responsibility to fix it in such a way to address the needs of ALL of it's residents, not just the new residents who aren't even here yet. I vote, I won't forget and I won't let everyone else who is affected by this forget either. They vote too.

Good morning School Board Members,

I'm copying my husband's message sent to you yesterday but wanted to add another note this morning after watching the video footage of last night's meeting. As my husband stated we're caught in a difficult place not wanting to speak out against our neighbors.... we still love our neighborhood and have lived here for 16 years. Both daughters age 12 and 9 have numerous friends they've been growing up with some who are still attending SSMS and some who chose to go to RRMS. I am a resident of Ellington Place that bumps up to Longleaf. (Area 12, Westside) We are our own subdivision. Our entrance is on State Road 54 and you can only exit to the right from our subdivision, towards Little Road. There is a street that connects us to Longleaf as their is a street that connects Fairway springs to Longleaf. This does not make that our entry or exit. But both Fairway Springs and Ellington are used for Longleaf residence to enter and exit their subdivision. Having three teenage children that are very active in our community I will tell you that I maybe exit out Longleaf 1 out of every 10 times merely because our community is the opposite direction. The exit out Longleaf is a four lane road that is extremely busy during peak hours. My 15 year old that's learning to drive hates to even exit that way.

Our schools are SSMS and JWMHS. Our Church is Generations Church across the street from the schools. We shop at Publix, Target and Walmart all on the corner of [54 and Little Road](#). All of these places are within 3 miles from our house. Please just stop for a moment and picture an evening of ours. The high School is having a sports game I drop off my daughter, it's a Tuesday so I then drive across the street to drop my son off at church. I run to the grocery store to pick up milk and a few things after working all day. I drop the groceries off at home and then return to the high school and Church to pick up the children. All the while my husband is coaching our youngest at the Dixie softball fields off Seven Springs Blvd. This is just one example of how tight our time is. This would not be possible if we were rezoned to a school that was 3x farther away from our house.

My next concern is if you approve moving Ellington and Longleaf to River Ridge then you would be leaving only ONE Subdivision from Longleaf Elementary School's feeder pattern going to SSMS and that would be Fairway Springs. I attended the board meeting two nights ago and wanted to submit a map proposal after hearing your shared information and the question/answer period.

It was shared by Chris Williams that "Starkey K-8 is on track to open 2021 and will be zoned for only Starkey Ranch and Astoria".

We are aware that Kurt Browning wants to "split the growth", but our question is why? This has not been answered.

My suggestion is since we know the students of Astoria and Starkey Ranch will go together exclusively to Starkey K-8 in two years four months, then why are you not allowing them to stay together now? What difference is two years going to make on SSMS? **This is a sincere question that I would like to formally request be answered.**

In the past, it has been brought up that Astoria was too far of a drive to River Ridge. However, just this morning during school traffic I drove it myself and clocked it. I have attached the photos of my mileage. It is a five minute difference for Astoria to drive to River Ridge schools than SSMS/JWMHS. This was calculated from "sign to sign". It would take them 16 minutes and is a 11.4 mile drive. This distance has been exceeded in the past by Pasco County Schools. For example, when Oak Ridge (West side of Seven Springs Blvd.) attended River Ridge schools. Astoria currently drives 11 minutes (6.9 miles) to SSMS/JWMHS. These figures are legitimate drive time-not google or map quest.

Proposal:

1. Keep Starkey Ranch/Astoria children together.
2. Keep Longleaf, Ellington, Sienna Woods (area 12) in their community.
3. Don't break the feeder pattern of areas 12/13 being split up and have the small area of 13 going to a middle school they do not know anyone at. Under the proposed map, area 13 will go to school with children for 6 years at Longleaf Elementary and then go to SSMS knowing nobody and the rest of their established group of relationships would go to RR schools. This is just wrong.
4. Keep Longleaf, Ellington, Sienna Woods at a school close to home-SSMS/JWMHS (they will have two middle schools within two miles in two years they could attend. Use logical/common sense and let them).
5. Use Starkey Blvd/54 quadrant as a boundary, not the Longleaf Elementary School playground as it is on the proposed map.
6. Don't split new growth.
7. **Do not force students to give up their seats for children that do not exist yet.**
8. Astoria currently only has 15 middle schoolers and 11 high schoolers. Additional children/families would have a choice about the school they would be attending before deciding to build in Astoria unlike area 12.
8. **Longleaf Town Hall has an engraved plaque that states Established 2001 on the front porch. Please do not uproot them from their community school for a development that is not developed.**
9. Do not add new growth to SSMS/JWMHS
10. Longleaf neighborhood 5 proposed growth is only 75 homes (not 80) and is not connected to Longleaf and is gated. Neighborhood 5 has much more of a division than we have from Fairway. The 75 homes could go to RR schools. Neighborhood 4 has not even been bought by a builder yet and has been for sale for ten+ years. It could be another ten years before it is/if ever purchased and could go to RR schools as well. For the record, Pulte homes has pulled out of Longleaf as of a few weeks ago and will not be building in here anymore. It is a long way off before that neighborhood is a thought again. Please do not see Longleaf as a new growth area. It is not.
11. Currently only 54 students total from area 12 are at River Ridge schools per your report online (attached). It states from area 12 only 21 went to RRHS and 41 to RRMS. Then if you subtract the 3 high and 5 middle (per Linda Cobbe's email) that returned to SSMS/JWMHS you really only have the 54 that

ended up at RR total. **Can someone honestly tell me moving these 54 children is worth the headache that all of these children and families are having to live through? Real living breathing children are experiencing grades dropping, they are losing sleep, and they are unable to focus on school. This is another question we would like answered. How is moving these 54 students relieving SSMS/JWMHS? How can we not take this personal?**

12. Wendell Krinn Tech. High is taking 77 students from Mitchell High - another 77 empty seats at JWMHS.

13. Sending Asturia to SSMS/JWMHS now and for the next two years four months is going to lead them to establish their roots in the SSMS/JWMHS community of families/friends/neighborhoods. Then to be moved again with students/relationships they do not have (since they will have never been given the opportunity to go to school with the families of Starkey Ranch) is going to cause an uproar. You will have the Asturia parents sitting in the board meetings telling you they want to stay at SSMS/JWMHS in under two years when the boundary process begins for Starkey K-8. Avoid that now and allow them to start getting to know the families they will be with. Keep the Starkey Ranch and Asturia families together. They are directly next door to each other.

14. Keep the rest of the map as it is (area 30) to allow the west of Seven Springs Blvd. to be slated for PRSMS/AHS if room should be needed in the future at SSMS/JWMHS.

Please do what is right for the community and most importantly these children. Let these children of area 12 have some peace in their lives knowing they did not get removed for children that do not exist yet. The current map is basically the same exact map as the judge voided and frankly does not make any sense. We need leadership in this district to guide/form the boundaries for future growth. Use Starkey Ranch Blvd. as a boundary.

Dear Pasco County School Board,

With the amount of power you hold over my family's future, I hope you read my letter in it's entirety. This includes what I think is a really great alternative plan! Thank you.

After attending the school board meeting last Tuesday, I have to admit I'm more concerned than ever. I feel incredibly unheard. How can I trust that you are truly listening and trying to understand our situation when the end of the meeting was so obviously choreographed to dismiss any concern we have? If those are the only questions you have, and if the answers you did receive somehow justified this rezone, I'm at a loss. How do you think it feels when we are told that address verification just has too many obstacles for almost two years, but then it was somehow done in a matter of 3 days? Then followed with an explanation that there really needs to be more discussion within the school board if it could continue in the future because it seems unfair to kick out a child that they find is attending school illegally???! The "small number" of kids they said they did find in a preliminary search is right in line with the number of students you're considering moving from our neighborhoods!!! How is that number of students almost brushed off to be insignificant in that meeting, yet our extremely similar number of kids is so significant, it requires another rezone?? I feel like I'm in the twilight zone. I feel like common sense left the room a long time ago. Did we really need a real estate expert to tell us that homes sold recently had higher prices than homes sold years ago? That is true almost everywhere. I would really like you to look at the number of kids who choiced back in to SSMS/Mitchell. The percentages per grade are the overwhelming majority! The percentages decreasing as grade level decrease is interesting, but they don't take into account a couple of items. High school students would be able to take advantage of School Choice easier just due to their age. These students are of driving age or have friends who can take them to school. This reduces the hardship of needed transportation from

parents. Regardless, the numbers are high for all grades except 6th. When 70-90% of kids choice back in to their schools, that has to send a powerful message. What those numbers don't tell us is how many more applied, but were denied Choice? Those already high percentages would be even higher! I can't tell you the dozens of parents who were beside themselves when they found out we, the choice families, were ultimately able to get a bus because they're kids were unhappy to have been moved, and they either hadn't applied or didn't accept an approval for choice because they just couldn't handle the burden of transportation. The overwhelming majority of our neighborhoods want to stay at SSMS/Mitchell! As for the families who want to stay at River Ridge feeling afraid to speak out, I wholeheartedly disagree. When Cynthia Armstrong visited our neighborhood, we welcomed a RR parent. We welcomed her to speak. We supported her. When the one of two RR parents spoke at the school board meeting, we applauded their speeches. We support one another. We've all been thrown into a super unfair situation through NO fault of any of us! In our neighborhood, we care about one another's children. This commitment to this issue for TWO YEARS is NOT because of some rumors about the school! This commitment to this issue is because the proposed rezone is WRONG!

You may be thinking that maybe voting "yes" to Mr. Browning's plan will ultimately be "okay" because we can all just choice back in again. However, Mr. Browning has made comments multiple times about making massive cuts to Choice. There was an article just last week quoting Browning on this subject. SSMS/Mitchell were on the list of schools he plans to cut. In addition, my daughter is an incoming 9th grader! She's one of the first to be cut because she's seen as starting a new school anyway. Whether or not you reset Choice does not matter in her situation. The incoming 9th graders are in a very lonely spot as they are singled out and not grandfathered anywhere because it's seen as "starting a new school". For these schools, this couldn't be further from reality. These schools are on the same campus! They share their athletic fields, buses, etc..... she already feels like a Mustang! It's not as if there is already a split feeder pattern and some kids just do go to another school. Our very small group of kids will be singled-out and taken from anything familiar to them at what is already a really tough age.

The point made about the feeder pattern at last week's meeting made a giant neon light go off about what makes sense here! If Austoria and Starkey Ranch are slated to go to the new Starkey K-8 in 3 or less years, WHY would we not create continuity in the feeder pattern??? Why would we create a situation where we'll be right back here rezoning people in a couple years??? It only makes sense for Starkey Ranch and Austoria to go to River Ridge. Leave Longleaf and Ellington at SSMS/Mitchell! Longleaf will never attend Starkey K-8. There was talk of the growth within Longleaf. The growth coming from Longleaf will be much less than Starkey Ranch/Austoria, but also much further into the future! It makes sense to send the immediate growth to the schools with the most vacancy right now, which is River Ridge. Also, the least growth (Longleaf) to the schools with the least vacancy! Then, Starkey K-8 will come in 3 short years and the feeder pattern can be maintained there. Meanwhile, we're following the goals stated by the school board, that is splitting the growth (Longleaf's growth) later down the road to SSMS/Mitchell. This also makes sense for so many reasons stated before,

including keeping neighborhood integrity with Fairway Springs! This keeps Longleaf/Ellington/Fairway Springs together in a common feeder pattern considering we're one big neighborhood for all intents and purposes. This is exactly what the school board keeps saying their goal is- to split the growth! It's just a way to do it that makes more sense considering Longleaf's growth isn't immediate. I am so glad this was pointed out at the meeting because it makes all the sense in the world! I'm really excited about this plan. It fixes everyone's concerns and is a true win-win solution!!!

We are counting on you. Our children are counting on you to do what is right. Don't do what is easy. Don't rubber stamp a plan that makes ZERO sense! Your constituents are begging you to work for them! Do the right thing. Anyone who has ever seen the distance from our neighborhoods to our schools..... anyone who has driven around our neighborhoods to see what we're saying about being neighborhoods with three names, but really we're just one big neighborhood..... anyone who has listened to these families and knows how rare it is to keep busy, working people THIS engaged for THIS long..... anyone who has kids and understands the overwhelming hardship of taking away the YMCA that so many count on to make life "work".....anyone who has looked at the maps and the numbers.... anyone who knows kids and knows how detrimental bussing them off 9 miles away to an unfamiliar community would never choose this plan as the right plan. The school board should not adopt a bad plan! I'm not sure you feel any allegiance to my family, but we are counting on you to do the right thing! We've worked really hard to purchase our home. We built our home 2 miles away from our chosen schools because "who would ever move people who are 2 miles away!?!?!?!?!?!?!?! We built our life HERE! You can not imagine the hard work and sacrifices we made to build almost a half million \$ home, at the height of the market, in our twenties, for our kids' futures. We have a 3rd grader coming up. We want her at these schools too. Somehow, with all the hard work and planning, our lives plans rest on you, a small group of strangers. I'm not sure how we got here. In another space and time, we could be fighting for a bus because some of us are under 2miles away. Whatever generosity, kindness, common sense or consideration was given to the large amount of West side families who were to be rezoned as well, can we have some of that??? Kindness? Consideration? Common sense??? We need you to ask more questions. We need you to really expect answers that make sense. My family needs you to stand up for us. Please don't let us down! Please look at this new plan I suggested! This makes so much more sense!!!

Dear Pasco County School Board Members and District Staff,

I attended the special meeting this past week and have a few comments I'd like to share.

Two concepts were repeatedly mentioned, not only in this week's meeting, but also in the boundary committee meetings. Splitting the growth and keeping feeder patterns. It was also mentioned, I believe by Ms. Armstrong and/or Mr. Williams, that the intent of moving Longleaf/Ellington would be something that wouldn't be an immediate fix to the overcrowding, but rather happen slowly once 6th graders start to filter in.

Here is some background information: Longleaf neighborhood 4 is quite a ways out from being developed. There was a contract on the table but the builder Pulte pulled out. This development is slotted to have approximately 387 homes. Longleaf neighborhood 5 is currently building homes and is slotted to have approximately 75 homes. As you know Starkey Ranch and Asturia are much further along in their development. Another fact is that the Starkey K-8 is on track to open in the fall of 2021.

Considering the two concepts of splitting new growth and not breaking up feeder patterns, wouldn't it make sense to pair up Starkey Ranch and Asturia to go to

River Ridge? Here is some rationale as to why that may make sense. These are the two developments that are further along and in the near future have a connecting road to the new community Publix that will serve as the community Publix to both these neighborhoods, and River Ridge has more capacity at this point than SSMS/Mitchell does. Then, since both these communities will be going to Starkey K-8 in 3 years, it will maintain the feeder pattern. 3 years will be here before we know it. This rezone has already been going on for almost 2 years. By that time, Longleaf neighborhood 4 will be further along in development and continue into feeding into SSMS/Mitchell.

In summary, split the new growth by splitting Longleaf N4 & N5 with Starkey Ranch & Asturia. The developments that are moving along quicker, will go to the schools with more vacancy (the only schools of the two campuses with vacancy, actually). Maintain feeder patterns by keeping Starkey Ranch and Asturia together feeding into RR coming from Starkey K-8, and Longleaf neighborhoods 1 through 5 together feeding into SSMS/Mitchell. This also fixes the problem of subdivision integrity because it keeps the interconnected subdivisions of Ellington, Longleaf, and Fairway Springs together.

I hope that you will consider running the numbers on this idea and gathering some data. It may be a viable solution and keep the children of established communities at their home school while still splitting new growth. It also puts the new growth that is developing the fastest in schools with the most capacity (comparing River Ridge and SSMS/Mitchell, as it is understood that Ancloste/Paul R Smith will not be taking any overflow to bring up their numbers).

In the past, it has been brought up that Asturia was too far of a drive to River Ridge. However, just this morning during school traffic I drove it myself and clocked it. I have attached the photos of my mileage. It is a five minute difference for Asturia to drive to River Ridge schools than SSMS/JWMHS. This was calculated from "sign to sign". It would take them 16 minutes and is a 11.4 mile drive. This distance has been exceeded in the past by Pasco County Schools. For example, when Oak Ridge (West side of Seven Springs Blvd.) attended River Ridge schools. Asturia currently drives 11 minutes (6.9 miles) to SSMS/JWMHS. These figures are legitimate drive time-not google or map quest.

Proposal:

1. Keep Starkey Ranch/Asturia children together.
2. Keep Longleaf, Ellington, Sienna Woods (area 12) in their community.
3. Don't break the feeder pattern of areas 12/13 being split up and have the small area of 13 going to a middle school they do not know anyone at. Under the proposed map, area 13 will go to school with children for 6 years at Longleaf Elementary and then go to SSMS knowing nobody and the rest of their established group of relationships would go to RR schools. I have attached the photos of my mileage. It is a five minute difference for Asturia to drive to River Ridge schools than SSMS/JWMHS. This was calculated from "sign to sign". It would take them 16 minutes and is a 11.4 mile drive. This distance has been exceeded in the past by Pasco County Schools. For example, when Oak Ridge (West side of Seven Springs Blvd.) attended River Ridge schools. Asturia currently drives 11 minutes (6.9 miles) to SSMS/JWMHS. These figures are legitimate drive time-not google or map quest.

Proposal:

1. Keep Starkey Ranch/Asturia children together.
2. Keep Longleaf, Ellington, Sienna Woods (area 12) in their community.
3. Don't break the feeder pattern of areas 12/13 being split up and have the small area of 13 going to a middle school they do not know anyone at. Under the proposed map, area 13 will go to school with children for 6 years at Longleaf Elementary and then go to SSMS knowing nobody and the rest of their established group of relationships would go to RR schools. This is just wrong.
4. Keep Longleaf, Ellington, Sienna Woods at a school close to home-SSMS/JWMHS (they will have two middle schools within two miles in two years they could attend. Use logical/common sense and let them).
5. Use Starkey Blvd/54 quadrant as a boundary, not the Longleaf Elementary School playground as it is on the proposed map.
6. Don't split new growth.
7. **Do not force students to give up their seats for children that do not exist yet.**
8. Asturia currently only has 15 middle schoolers and 11 high schoolers. Additional children/families would have a choice about the school they would be attending before deciding to build in Asturia unlike area 12.
8. **Longleaf Town Hall has an engraved plaque that states Established 2001 on the front porch. Please do not uproot them from their community school for a development that is not developed.**
9. Do not add new growth to SSMS/JWMHS
10. Longleaf neighborhood 5 proposed growth is only 75 homes (not 80) and is not connected to Longleaf and is gated. Neighborhood 5 has much more of a division than we have from Fairway. The 75 homes could go to RR schools. Neighborhood 4 has not even been bought by a builder yet and has been for sale for ten+ years. It could be another ten years before it is/if ever purchased and could go to RR schools as well. For the record, Pulte homes has pulled out of Longleaf as of a few weeks ago and will not be building in here anymore. It is a long way off before that neighborhood is a thought again. Please do not see Longleaf as a new growth area. It is not.
11. Currently only 54 students total from area 12 are at River Ridge schools per your report online (attached). It states from area 12 only 21 went to RRHS and 41 to RRMS. Then if you subtract the 3 high and 5 middle (per Linda Cobbe's email) that returned to SSMS/JWMHS you really only have the 54 that ended up at RR total. **Can someone honestly tell me moving these 54 children is worth the headache that all of these children and families are having to live through? Real living breathing children are experiencing grades dropping, they are losing sleep, and they are unable to focus on school. This is another question we would like answered. How is moving these 54 students relieving SSMS/JWMHS? How can we not take this personal?**
12. Wendell Krinn Tech. High is taking 77 students from Mitchell High - another 77 empty seats at JWMHS.
13. Sending Asturia to SSMS/JWMHS now and for the next two years four months is going to lead them to establish their roots in the SSMS/JWMHS community of families/friends/neighborhoods. Then to be moved again with students/relationships they do not have (since they will have never been given the opportunity to go to school with the families of Starkey Ranch) is going to cause an uproar. You will have the Asturia parents sitting in the board meetings telling you they want to stay at SSMS/JWMHS in under two years when the boundary process begins for Starkey K-8. Avoid that now and allow them to start getting to know the families they will be with. Keep the Starkey Ranch and Asturia families together. They are directly next door to each other.
14. Keep the rest of the map as it is (area 30) to allow the west of Seven Springs Blvd. to be slated for PRSMS/AHS if room should be needed in the future at SSMS/JWMHS.

Please do what is right for the community and most importantly these children. Let these children

In response to your request please find attached the following maps with projections as posted on our website during this rezoning process:

- i) Maps 5x
- ii) Superintendent's Recommended Maps (Maps 4a2x)
- iii) Maps 0x – since the LCRA did not specifically address changing boundary lines I assumed no change in attendance boundaries (other than Area 30) which is what Maps 0x represent

The amended LCRA proposed to rezone Starkey Ranch from Seven Springs Middle and JW Mitchell High to River Ridge Middle and High. This is in essence Maps 0x with Starkey Ranch rezoned. Starkey Ranch currently has 15 middle school students and 31 high school students. Per our growth table, the 5-year projected growth for Starkey Ranch is 270 middle school students and 355 high school students. So Maps 0x adjusted for Starkey Ranch would lead to a projection in Year 5 (without Starkey K-8) of 1940 for Seven Springs Middle, 2408 for JW Mitchell High, 1380 for River Ridge Middle and 1822 for River Ridge High.

In addition, I have attached the latest ADM projections for all schools for next year based on the most recent information I have available to me.

Thank you for your response. We have been in contact with the Pasco County planning department and have had Master Plans sent to us. After reading through them, if the focus must be to split the new growth, then we need to factor in the new Mitchell Ranch South development slated for 90 homes directly next door to the SSMS/JWMHS campus. Additionally, we need to factor in that the Longleaf neighborhood 4 is back to not being developed again now that Pulte homes has officially pulled out. If you consider both of these items, then this gives even more reason to send Asturia to RR schools, keep area 12 in SSMS/JWMHS schools, and keep the only two neighborhoods going to the Starkey K-8 together starting now.

I would like to ask why the new growth MUST be split with only 2.4 years before Starkey K-8 opens? Seems silly to split them for that short amount of time. Back then the boundary committee made this decision thinking Longleaf would have neighborhood 4, which Pulte has backed out of and is no longer in the plan.
