Software House International (SHI)

The District has a volume license agreement with FileMaker Inc., allowing use of the entire family of FileMaker products. This software is used extensively throughout the District, from individual desktop databases to District-wide enterprise applications.

The Information Services Department is requesting software support for this product line (please reference the detailed memo attached from Mr. Bruce Baldwin, Director of Information Services.) The expenditure of \$64,750 to Software House International (SHI) will be funded through capital outlay, and is permitted without formal bid under Florida Administrative Rule 6A-1.012(14). The price has been deemed competitive based negotiation, as permitted by the above-referenced Rule. The term of the support will be December 1, 2009 – October 31, 2010.

The District School Board of Pasco County has a volume license agreement with FileMaker, Inc. that allows the district to use the entire family of FileMaker products, including server and handheld software, as needed. As you know, FileMaker software continues to be used extensively throughout the system from individual desktop databases to district-wide enterprise solutions.

The cost of software support has increased as on this product line as expected, but I have been able to negotiate a discount with FileMaker that has been extended to their resellers. The low bid received from 3 quotes is from SHI in the amount of \$64,750. We are therefore requesting permission to place a purchase order in this amount to SHI, funded through capital outlay. Approval of this purchase order will allow the continuation of district-wide deployment of FileMaker software with free upgrades through October 2011, and it will save the district \$19,250.00 by taking action prior to the end of 2009.
