Negotiated Contract for Student Athletic Insurance

School Insurance of Florida

Since August 2006, the District has contracted with School Insurance of Florida (SIF) for the purchase of athletic accident/injury insurance for interscholastic athletic teams. The original contract was the result of RFP 07-011-DO, Board approved July 11, 2006.

The Employee Benefits, Assistance & Risk Management Department (EBARM) is requesting permission to continue using the services of SIF for the term August 1, 2011 - July 31, 2012. Please reference the attached memo from Ms. Mary Tillman, Director of EBARM, for detailed information. Under Florida Administrative Rule 6A-1.012(15) the District is permitted to negotiate for insurance services, should it be in the Board's best interest to do so.

SIF has held its pricing firm for the District since 2007. The cost of \$145,447.66 will be funded through risk management insurance general funding. Under this same agreement, the voluntary student accident insurance plan available for purchase by parents/guardians will also be renewed at last year's rates. For this optional policy, there is no cost to the District.

We are requesting Board signature on the attached renewal, and permission to issue a purchase order to SIF in the amount of \$145,447.66 for encumbrance in the next fiscal year. Should you have any questions or concerns, please contact Mary Tillman or me at your earliest convenience.

2010-11 Renewals for School Insurance of Florida, Inc.

The Board awarded the student athletic insurance (RFP 07-011-DO) to School Insurance of Florida on July 11, 2006. The RFP was a three-year contract, with annual renewals based on the mutual consent of the parties. A one year extension of the contract expires on July 31, 2011.

For the 2011-12 school year, School Insurance of Florida proposes an athletic insurance renewal at the current policy cost of \$145,447.66.

At this time, it is my recommendation to renew with School Insurance. I am requesting that the District continue the contract with School Insurance of Florida, without formal bid action under the Florida DOE Rule 6A exemption for insurance, for the following reasons:

- The vendor is renewing with no premium increase.
- The coverages will remain the same as in past years.
- The dollars involved are comparatively low.
- Service from this vendor has been satisfactory.

Under this same agreement, the voluntary student accident insurance plan available for purchase by parents/guardians will also be renewed at the same rates as last year. There is no cost to the District for this policy.

Please request permission from the Board to approve this renewal. If you have any questions or need any additional information, please call me. As always, I appreciate the assistance that I have received from you and your staff during this process.
